

(57) ABSTRACT

Autonomous vehicles may include one or more onboard devices to perform various actions, such as a still image capture device. In contrast with using an auxiliary communication system to control a payload, a vehicle navigation sensor is used to monitor autonomous vehicle movements to match a predefined vehicle maneuver event, and trigger a payload event based on identification of the vehicle maneuver event. For example, this allows an autopilot system or a remote drone pilot to initiate an image capture device or send other commands based on vehicle maneuver event recognition.












AUTONOMOUS VEHICLE MANEUVER RECOGNITION

TECHNICAL FIELD

Embodiments described herein generally relate to vehicle navigation sensors.

BACKGROUND

There is an increasing use of autonomous vehicles, such as for surveillance, package delivery, and personal transportation. Autonomous vehicles may be completely autonomous, using one or more locations (e.g., waypoints) to define origins, destinations, or observation targets. ¹⁵ Examples of completely autonomous vehicles may include unmanned aerial vehicles (UAVs) or "self-driving" cars. Autonomous vehicles may be partially autonomous, which may use a combination of locations and operator input to perform actions or travel between locations. An example of ²⁰ a partially autonomous vehicle may include remotely operated UAVs or remotely operated aerial drones.

Autonomous vehicles may include one or more payloads (e.g., onboard devices) to perform various actions, such as a still image capture device (e.g., a camera). Control of such ²⁵ payloads requires an auxiliary communication system. Such auxiliary communication systems can be expensive and may affect the navigation performance or flight performance of the vehicle. To avoid the need for an auxiliary communication system, many payload installations wastefully operate in an always-on state, which consumes power and data storage resources at all times. For location-specific or time-specific payloads such as cameras, the always-on state captures images outside of the intended target of interest. It is desirable to provide improved control over autonomous ³⁵ vehicle payloads.

BRIEF DESCRIPTION OF THE DRAWINGS

FIG. 1 is a block diagram of an example autonomous ⁴⁰ vehicle gesture recognition system, in accordance with at least one embodiment of the invention.

FIG. 2 is a graph of a single vehicle maneuver detection, in accordance with at least one embodiment of the invention.

FIG. 3 is a graph of a multiple vehicle maneuver detection, in accordance with at least one embodiment of the invention.

FIG. 4 is a graph of instantaneous measurement detection, in accordance with at least one embodiment of the invention.

FIG. **5** is a graph of asynchronous serial communication 50 maneuver detection, in accordance with at least one embodiment of the invention.

FIG. 6 is a block diagram graph of an autonomous vehicle maneuver recognition method, in accordance with at least one embodiment of the invention.

FIG. 7 is a block diagram illustrating an autonomous vehicle navigation system in an example form of an electronic device, according to an example embodiment.

DESCRIPTION OF EMBODIMENTS

The present subject matter provides a technical solution for various technical problems in providing control over autonomous vehicle payloads. In an embodiment, a vehicle navigation sensor (e.g., an inertial measurement system) is 65 used to monitor autonomous vehicle movements to match a predefined "vehicle gesture pattern" (e.g., vehicle maneuver

event), and trigger a payload event based on identification of the vehicle gesture pattern. For example, this would allow an autopilot system or a remote drone pilot to cue an image capture or another function on a drone payload system by flying a predefined maneuver.

The following description and the drawings sufficiently illustrate specific embodiments to enable those skilled in the art to understand the specific embodiment. Other embodiments may incorporate structural, logical, electrical, process, and other changes. Portions and features of various embodiments may be included in, or substituted for, those of other embodiments. Embodiments set forth in the claims encompass all available equivalents of those claims.

FIG. 1 is a block diagram of an example autonomous vehicle gesture recognition system 100, in accordance with at least one embodiment of the invention. Example system 100 includes an autonomous vehicle 110, such as an autonomous quadrotor helicopter equipped with a camera to take pictures of a field 120. Vehicle 110 may depart from a landing pad 130 using a predefined departing path 140.

In an embodiment, the camera installed on the vehicle 110 takes photos 150 at regular intervals along the departing path 140. Vehicle 110 may continue to take photos 150 at regular intervals while traversing the departing path 140 and while performing initial maneuver 160. Upon performing the initial maneuver 160, the vehicle 110 may continue taking pictures at regular intervals along a flight path 170. When the vehicle 110 has completed flight path 170, vehicle 110 performs a final maneuver 180 and returns along a return path 190 to landing pad 130.

The initial maneuver 160 and final maneuver 180 may include a suboptimal navigation maneuver (e.g., nonstandard navigation maneuver). As used herein, "suboptimal navigation maneuver" includes a maneuver that results in a desired change in the vehicle orientation or movement, but is accomplished through a maneuver other than an optimal maneuver. For example, a suboptimal navigation maneuver may include a 270-degree counterclockwise rotation, which results in the same final direction as an optimal 90-degree clockwise rotation. A suboptimal navigation maneuver may include a suboptimal combination of maneuvers, such as using a 90-degree clockwise azimuth rotation (i.e., 90-degree change in yaw) followed by a 90-degree upward rotation (i.e., 90-degree change in pitch) instead of completing the two rotations simultaneously. Suboptimal navigation maneuvers may include other maneuvers or combinations of maneuvers.

A navigation maneuver identification system may identify the initial maneuver 160 and final maneuver 180 based on navigation data provided by navigation sensors within vehicle 110. The navigation sensors may provide various types and combinations of output navigation data. For example, the navigation sensor may include an inertial measurement unit (IMU), which may include an accelerometer and gyroscope to output vehicle roll, pitch, yaw, acceleration, or approximate velocity calculated based on acceleration. The navigation sensor may include a compass to provide heading or a global navigation satellite system (GNSS), such as the Global Positioning System (GPS) to 60 provide location. In an example, the navigation sensor includes a tightly coupled IMU and GNSS system, where the IMU data is used to reduce noise in the GNSS positioning accuracy and the GNSS data is used to reduce inertial positioning noise (e.g., drift).

The navigation maneuver identification system may be embedded on the vehicle 110, and may discard images before the initial maneuver 160 and after the final maneuver

180. The navigation maneuver identification system may be executed on a ground-based computer, which may post-process navigation data and camera images, and select a relevant subset of image data between the initial maneuver 160 and the final maneuver 180.

In an embodiment, vehicle 110 is configured to begin taking photographs in response to identifying the initial maneuver 160. For example, navigation maneuver identification system may be embedded on the vehicle 110, and upon identifying the initial maneuver 160, the navigation 10 maneuver identification system may switch on a camera or send a command to a camera to begin taking photos at regular intervals. In contrast with operating a payload continuously throughout an entire flight, this remote maneuver identification enables the vehicle 110 to initiate or terminate 15 payload operation at a desired time or location. This also enables a remote user to execute payload functionality by controlling vehicle 110 to execute various maneuvers without requiring a separate communication system to control the payload. This remote user input may include a user input 20 of one or more maneuvers for an autonomous or nonautonomous vehicle. For example, a user input may include controlling a partially autonomous UAV to execute a 360degree turn to initiate payload operation. In another example, a non-autonomous vehicle may be completely 25 controlled by a user, and the user may execute a 270-degree turn to bring about the same orientation as a desired 90-degree turn.

Vehicle 110 may include a control system to cause one or more maneuvers to execute payload functionality. For 30 example, vehicle 110 may include a navigation path that includes predetermined waypoints that define a predetermined vehicle travel path. The waypoint information may also include a location or a travel path segment in which to execute payload functionality. The vehicle 110 may analyze 35 the waypoints and payload functionality segments to identify a suboptimal maneuver. For example, vehicle 110 may determine that an optimal maneuver between the departing path 140 and start of flight path 170 would include a rotation of approximately 120 degrees (i.e., a right turn), and may 40 instead execute a suboptimal rotation of approximately -240 degrees (i.e., a left turn) to result in approximately the same final orientation as the 120 degree turn. Other types of maneuvers may be used, such as adding one or more suboptimal changes in yaw, pitch, roll, or motion in one or 45 more directions.

In addition to taking photographs in response to identifying the initial maneuver 160, one or more additional image capture parameters may be configured based on the initial maneuver 160. For example, identifying the initial maneuver 160 may trigger a change in an image capture interval, where the interval may be based on a time interval between images, a distance traveled between images, or other interval. The image capture parameter may include adjusting an image capture overlap percentage, where the overlapping portions of the images may be used subsequently to join (e.g., stitch) multiple images into a larger image. The image capture parameter may also include an image capture exposure, an image capture focal point, or other image capture parameter.

While the example autonomous vehicle gesture recognition system 100 is described with respect to activation of a camera, other types of payloads may be triggered or configured based on the initial maneuver 160. For example, vehicle 110 may include a radio frequency (RF) energy 65 detection device. The RF energy detection device may be triggered to capture RF measurements in various locations,

where the RF measurements and locations may be used to generate an RF map such as a cellular coverage map. In another example, vehicle 110 may include a range detection device to capture range measurements, where the range measurements may be used to generate a three-dimensional range map. The range detection device may include a laser-based light detection and ranging (LIDAR) device, a radio detection and ranging (RADAR) device, an optical rangefinder, a sonic rangefinder, or other range detection device.

FIG. 2 is a graph of a single vehicle maneuver detection 200, in accordance with at least one embodiment of the invention. The first vehicle maneuver detection 200 shows a vehicle direction 210 as a function of time. The vehicle direction 210 shows the vehicle starting at 0 degrees, rotating to almost -180 degrees, and rotating back toward 180 degrees. The first vehicle maneuver detection 200 includes a moving maneuver time window 220, where the maneuver time window has an associated width (i.e., duration) and magnitude (i.e. minimum rotation threshold in degrees). The vehicle direction 210 is examined at various time intervals, and a maneuver is detected when a rotation occurs within the duration of the time widow 220 and exceeds a minimum rotation threshold. The predetermined rotation may be used to identify a suboptimal rotation around a particular axis, such as a change in yaw that exceeds a 180-degree minimum rotation threshold. Various time window durations or magnitudes may be used for different axes, such as to detect a change in vaw of at least 180 degrees simultaneously occurring with a change in roll of at least 30 degrees. The moving time window 220 duration and magnitude may also be selected to reduce or eliminate falsely identifying maneuvers. For example, as shown in first vehicle maneuver detection 200, a slow 360-degree rotation may not be detected, but a 360-degree rotation that occurs within time window 220 may be identified as a detected maneuver.

FIG. 3 is a graph of a multiple vehicle maneuver detection 300, in accordance with at least one embodiment of the invention. The second vehicle maneuver detection 300 shows an example of maneuver detection using multiple maneuver windows. A first maneuver window 310 may detect a first maneuver and a second window 320 may detect a second maneuver. A multiple maneuver window 330 may be used to identify when the first and second maneuvers occur within a predetermined multiple maneuver duration.

The first and second maneuvers may be similar, such as detecting a positive (i.e., clockwise) rotation exceeding a positive 180-degree threshold and detecting a negative (i.e., counterclockwise) rotation exceeding a negative 180-degree threshold. The first and second maneuvers may include different threshold values or may occur within different types of maneuvers (e.g., different navigation degrees of freedom). For example, the first and second maneuvers may include a clockwise rotation while ascending, or may include a counterclockwise rotation while descending.

The multiple vehicle maneuver detection 300 may be used to provide additional payload control. For example, a first maneuver may be used to initiate a timed sequence of camera images, and a second maneuver executed within a multiple maneuver window 330 may be used to terminate the timed sequence of camera images. In an embodiment, the vehicle delays initiating a payload until the multiple maneuver window 330 has elapsed to ensure that the multiple maneuver window 330 does not include both a first and second maneuver. The multiple maneuver window 330 may be used to correct an inadvertently executed maneuver, such as when a wind gust blows a UAV off course. The multiple

maneuver window 330 may be used to increase the complexity (e.g. bit depth) of commands sent to a vehicle through maneuvers. For example, detection of both a first maneuver and a second maneuver within the multiple maneuver window 330 may execute a multiple-maneuver 5 command.

The multiple maneuver window 330 may be used to determine a time delay for detection of one or more maneuvers. For example, when a first maneuver is detected within the first window 310, the multiple vehicle maneuver detection 300 may delay for the width (i.e. duration) of the multiple maneuver window 330 to allow for a possible detection of a second maneuver. In this example, detection of a second maneuver within the multiple maneuver window 330 executes the multiple-maneuver command, whereas no 15 detection of a second maneuver within the multiple maneuver window 330 executes the first command associated with detection of the first maneuver.

The multiple maneuver window 330 may also be used to command a particular combination of commands, such as 20 executing three different commands based on detection of two maneuvers. For example, a first maneuver detected within the first window 310 executes a first command, a second maneuver detected within the second window 330 executes a second command, and the combination of the first 25 and second maneuvers detected within the multiple maneuver window 330 executes a third command. Various combinations of maneuver windows may be applied to different types of navigation outputs, thereby significantly increasing the number and complexity of command messages that can 30 be conveyed to the vehicle. This detection of multiple maneuvers within specific time windows may be used to conduct synchronous serial communication, such as where execution of multiple maneuvers occurs at a predetermined rate. While FIG. 3 depicts time windows, vehicle maneuver 35 detection may be based on an instantaneous measurement (e.g., a single navigation sensor sample), such as shown in

FIG. 4 is a graph of instantaneous measurement detection 300, in accordance with at least one embodiment of the 40 invention. In contrast with the use of one or more time windows, instantaneous measurement detection 300 includes identifying a maneuver based on a single navigation sensor data point. For example, the detected maneuver may include a rapid change in elevation 410, such as a rapid 45 ascent detected by an accelerometer or a position sensor (e.g., GPS). The instantaneous measurement 420 reflects the rapid ascent. The instantaneous measurement 420 may be identified at a predetermined time, or the instantaneous measurement 420 may periodically poll one or more navi- 50 gation sensors for data. The instantaneous measurement detection 300 may detect other navigation parameters, such as a change in roll, pitch, yaw, position, velocity, or other navigation measurements. The instantaneous measurement detection 300 may use various maximum or minimum 55 thresholds to detect events. For example, the rapid change in elevation 410 may be compared against an ascent threshold, and a vehicle maneuver event may be identified when the ascent threshold is exceeded. Conversely, a slow change or a lack of change in a navigation measurement may be 60 compared against a threshold, and vehicle maneuver event may be identified when the threshold is not exceeded.

FIG. **5** is a graph of asynchronous serial communication maneuver detection **500**, in accordance with at least one embodiment of the invention. Detection **500** may include 65 using one maneuver type to transmit information, and a second maneuver type to indicate the beginning and ending

of the information transmission. Rephrased in terms of asynchronous serial communication, a first maneuver may be interpreted as a start bit, one or more interstitial communication maneuvers following the first maneuver may be interpreted as communication bits, and a final maneuver may be interpreted as a stop bit.

In the embodiment shown in FIG. 5, altitude 510 is used to indicate the beginning and ending of the communication session, and the compass direction 530 is used to provide the communication data. In particular, detection 500 identifies the start bit 540 when the altitude 510 exceeds an altitude threshold 520, then interprets multiple changes in direction 530, then identifies the stop bit 550 when the altitude falls back below the altitude threshold 520.

Other combinations of maneuvers may be used to convey information using asynchronous serial communication. For example, a UAV may descend below a communication altitude threshold to indicate a start bit, then rotate 720 degrees to command a camera shutter speed, and then ascend above the communication altitude threshold to indicate a stop bit. The start bit maneuver and stop bit maneuvers may be based a navigation sensor detection of a location, an orientation, a movement, or another navigation sensor output.

In addition to increasing command complexity, this maneuver-based asynchronous serial communication may be used to simplify maneuvers or to reduce false detection of unintended commands. For example, a 30-degree yaw rotation may be used within standard navigation, and that same 30-degree yaw rotation may be interpreted as a command when it is detected between a maneuver start bit and a maneuver stop bit. This allows more information to be encoded within smaller maneuvers, and therefore allows more information to be encoded within a shorter command duration. In some embodiments, the maneuver stop bit or another maneuver may be used as a maneuver parity bit or in another error-detection schema.

FIG. 6 is a block diagram graph of an autonomous vehicle maneuver recognition method 600, in accordance with at least one embodiment of the invention. Method 600 includes receiving vehicle navigation data 610 from a navigation sensor within a vehicle, selecting a data subset 620 of the vehicle navigation data, and identifying a vehicle maneuver event 630 within the data subset. The data subset of the vehicle navigation data may an instantaneous vehicle navigation measurement. The data subset may be associated with a predetermined maneuver window duration, and the predetermined maneuver window duration includes a plurality of vehicle navigation measurements.

Method 600 may include receiving 640 a plurality of predetermined waypoints, the plurality of predetermined waypoints defining a predetermined vehicle travel path, identifying a standard navigation maneuver based on a first waypoint and a second waypoint, the standard navigation maneuver including a first direction and a first magnitude in degrees, and causing the vehicle to execute a suboptimal navigation maneuver, the suboptimal navigation maneuver including a suboptimal navigation maneuver, wherein identifying a vehicle maneuver event within the data subset includes identifying the suboptimal navigation maneuver. The suboptimal navigation maneuver may include a second direction opposite from the first direction, and a second magnitude in degrees substantially equal to a difference between 360 degrees and the first magnitude in degrees. The standard navigation maneuver may include at least one of yaw, pitch, and roll, and the suboptimal navigation maneuver may include at least one of yaw, pitch, and roll that is not

included in the standard navigation maneuver. The suboptimal navigation maneuver may include a rotation greater than 180 degrees. In addition to or in place of predetermined waypoints, maneuver events may be received from a remote vehicle operator. For example, the first vehicle maneuver event or a subsequent vehicle maneuver event may occur in response to receiving a first or second navigation input event from a remote vehicle operator.

Method 600 may include executing 650 a first vehicle device action in response to identifying a vehicle maneuver event within the data subset. The vehicle device action includes causing an image capture device to adjust an image capture parameter. The image capture parameter may include an image capture interval. The image capture parameter may include an image capture overlap percentage. The 15 image capture parameter may include an image capture exposure. The vehicle method action may include causing the radio frequency energy detection method to capture a plurality of radio frequency measurements. Method 600 may include generating a radio frequency map based on the 20 plurality of radio frequency measurements. Method 600 may include generating a cellular coverage map based on the radio frequency map. Method 600 may include a range detection method, wherein the vehicle method action may include causing the range detection method to capture a 25 plurality of range measurements. Method 600 may include generating a three-dimensional range map based on the plurality of range measurements. The range detection method may include at least one of a laser-based light detection and ranging method, a radio detection and ranging 30 method, an optical rangefinder, and a sonic rangefinder.

Method 600 may include identifying a subsequent maneuver event 660 within the data subset. Method 600 may include interpreting the vehicle navigation data as asynchronous serial communication, the asynchronous serial communication including: identifying the vehicle maneuver event as a start bit, identifying at least one interstitial maneuver event as one or more serial communication bits, the at least one interstitial maneuver event occurring subsequent to the vehicle maneuver event, and identifying the 40 subsequent maneuver event as a stop bit, the subsequent maneuver event occurring subsequent to the at least one interstitial maneuver event.

Method 600 may include identifying a processing time window 670. The time window may include a first time 45 associated with the vehicle maneuver event and a second time associated with the subsequent maneuver event. Based on the first time and second time, and a processing time window is identified for post-processing of relevant data.

Method 600 may include executing a second vehicle 50 device action 680 in response to identifying the subsequent maneuver event within the data subset. Method 600 may include identifying that the vehicle maneuver event and subsequent maneuver event both occur within a predetermined event pair time window, and executing a third vehicle 55 device action in response to identifying that the vehicle maneuver event and subsequent maneuver event both occur within the predetermined event pair time window.

The received vehicle navigation data **610** may be provided by a vehicle navigation sensor. The vehicle navigation 60 sensor may include an inertial measurement unit, and the vehicle navigation data may include a plurality of inertial measurements. The inertial measurement unit may include a gyroscope, and the plurality of inertial measurements may include a plurality of rotation measurements. The inertial 65 measurement unit may include an accelerometer, and the plurality of inertial measurements may include a plurality of

acceleration measurements. The inertial measurement unit may include a compass, and the plurality of inertial measurements may include a plurality of compass heading measurements. The navigation sensor may include a global navigation satellite system device, and the vehicle navigation data may include a plurality of location measurements. The navigation sensor may include a tightly coupled inertial navigation system, the tightly coupled inertial navigation system providing a plurality of smoothed inertial measurements and a plurality of smoothed location measurements.

FIG. 7 is a block diagram illustrating an autonomous vehicle navigation system in an example form of an electronic device 700, within which a set or sequence of instructions may be executed to cause the machine to perform any one of the methodologies discussed herein, according to an example embodiment. Electronic device 700 may represent the vehicle shown in FIG. 1, or may represent an electronic device on which the maneuver detection occurs. In alternative embodiments, the electronic device 700 operates as a standalone device or may be connected (e.g., networked) to other machines. In a networked deployment, the electronic device 700 may operate in the capacity of either a server or a client machine in server-client network environments, or it may act as a peer machine in peer-to-peer (or distributed) network environments. The electronic device 700 may be implemented on a System-on-a-Chip (SoC), a System-in-a-Package (SiP), an integrated circuit (IC), a portable electronic device, a personal computer (PC), a tablet PC, a hybrid tablet, a personal digital assistant (PDA), a mobile telephone, or any electronic device 700 capable of executing instructions (sequential or otherwise) that specify actions to be taken by that machine to detect a user input. Further, while only a single electronic device 700 is illustrated, the terms "machine" or "electronic device" shall also be taken to include any collection of machines or devices that individually or jointly execute a set (or multiple sets) of instructions to perform any one or more of the methodologies discussed herein. Similarly, the term "processor-based system" shall be taken to include any set of one or more machines that are controlled by or operated by a processor (e.g., a computer) to execute instructions, individually or jointly, to perform any one or more of the methodologies discussed herein.

Example electronic device 700 includes at least one processor 702 (e.g., a central processing unit (CPU), a graphics processing unit (GPU) or both, processor cores, compute nodes, etc.), a main memory 704 and a static memory 706, which communicate with each other via a link 708 (e.g., bus). The main memory 704 or static memory 706 may be used to store navigation data (e.g., predetermined waypoints) or payload data (e.g., stored captured images).

The electronic device 700 includes a navigation sensor 710. Navigation sensor 710 may include an IMU, which may include an accelerometer and gyroscope to output vehicle roll, pitch, yaw, acceleration, or other inertial data. The navigation sensor 710 may include a compass to provide heading, or may include a GNSS to provide location. The navigation sensor 710 may include a tightly coupled IMU and GNSS system.

The electronic device 700 may further include a display unit 712, where the display unit 712 may include a single component that provides a user-readable display and a protective layer, or another display type. The electronic device 700 may further include an input device 714, such as a pushbutton, a keyboard, an NFC card reader, or a user interface (UI) navigation device (e.g., a mouse or touch-sensitive input). The electronic device 700 may additionally

include a storage device **716**, such as a drive unit. The electronic device **700** may additionally include a signal generation device **718** to provide audible or visual feedback, such as a speaker to provide an audible feedback or one or more LEDs to provide a visual feedback. The electronic device **700** may additionally include a network interface device **720**, and one or more additional sensors (not shown).

The storage device **716** includes a machine-readable medium **722** on which is stored one or more sets of data structures and instructions **724** (e.g., software) embodying or utilized by any one or more of the methodologies or functions described herein. The instructions **724** may also reside, completely or at least partially, within the main memory **704**, static memory **706**, or within the processor **702** during execution thereof by the electronic device **700**. The main memory **704**, static memory **706**, and the processor **702** may also constitute machine-readable media.

While the machine-readable medium 722 is illustrated in an example embodiment to be a single medium, the term 20 "machine-readable medium" may include a single medium or multiple media (e.g., a centralized or distributed database, and/or associated caches and servers) that store the one or more instructions 724. The term "machine-readable medium" shall also be taken to include any tangible medium 25 that is capable of storing, encoding or carrying instructions for execution by the machine and that cause the machine to perform any one or more of the methodologies of the present disclosure or that is capable of storing, encoding or carrying data structures utilized by or associated with such instruc- 30 tions. The term "machine-readable medium" shall accordingly be taken to include, but not be limited to, solid-state memories, and optical and magnetic media. Specific examples of machine-readable media include non-volatile memory, including but not limited to, by way of example, 35 semiconductor memory devices (e.g., electrically programmable read-only memory (EPROM), electrically erasable programmable read-only memory (EEPROM)) and flash memory devices; magnetic disks such as internal hard disks and removable disks; magneto-optical disks; and CD-ROM 40 and DVD-ROM disks.

The instructions **724** may further be transmitted or received over a communications network **726** using a transmission medium via the network interface device **720** utilizing any one of a number of well-known transfer protocols (e.g., HTTP). Examples of communication networks include a local area network (LAN), a wide area network (WAN), the Internet, mobile telephone networks, and wireless data networks (e.g., Wi-Fi, NFC, Bluetooth, Bluetooth LE, 3G, 5G LTE/LTE-A, WiMAX networks, etc.). The term "transmission medium" shall be taken to include any intangible medium that is capable of storing, encoding, or carrying instructions for execution by the machine, and includes digital or analog communications signals or other intangible medium to facilitate communication of such software.

In Example 116, the subject matter of any one or more of Examples 97-115 optionally include means for identifying a subsequent maneuver event within the data subset.

In Example 117, the subject matter of Example 116 optionally includes means for interpreting the vehicle navigation data as asynchronous serial communication, the asynchronous serial communication including: means for identifying the vehicle maneuver event as a start bit; means for identifying at least one interstitial maneuver event as one or more serial communication bits, the at least one interstitial maneuver event occurring subsequent to the vehicle maneuver event; and means for identifying the subsequent maneuver event as a stop bit, the subsequent maneuver event occurring subsequent to the at least one interstitial maneuver

In Example 118, the subject matter of any one or more of Examples 116-117 optionally include means for receiving a second navigation input to cause the subsequent maneuver

In Example 119, the subject matter of any one or more of In Example 104, the subject matter of any one or more of 55 Examples 116-118 optionally include means for identifying a first time associated with the vehicle maneuver event; means for identifying a second time associated with the subsequent maneuver event; means for identifying a processing time window for post-processing of relevant data, 60 the processing time window based on the first time and second time.

> In Example 120, the subject matter of any one or more of Examples 116-119 optionally include means for executing a second vehicle device action in response to identifying the subsequent maneuver event within the data subset.

> In Example 121, the subject matter of any one or more of Examples 116-120 optionally include means for identifying

that the vehicle maneuver event and subsequent maneuver event both occur within a predetermined event pair time window; and means for executing a third vehicle device action in response to identifying that the vehicle maneuver event and subsequent maneuver event both occur within the predetermined event pair time window.

In Example 122, the subject matter of any one or more of Examples 97-121 optionally include wherein: the navigation sensor includes an inertial measurement unit; and the vehicle navigation data includes a plurality of inertial measurements

In Example 123, the subject matter of Example 122 optionally includes wherein: the inertial measurement unit includes a gyroscope; and the plurality of inertial measurements includes a plurality of rotation measurements.

In Example 124, the subject matter of any one or more of Examples 122-123 optionally include wherein: the inertial measurement unit includes an accelerometer; and the plurality of inertial measurements includes a plurality of acceleration measurements.

In Example 125, the subject matter of any one or more of Examples 122-124 optionally include wherein: the inertial measurement unit includes a compass; and the plurality of inertial measurements includes a plurality of compass heading measurements.

In Example 126, the subject matter of any one or more of Examples 122-125 optionally include wherein; the navigation sensor includes a global navigation satellite system device; and the vehicle navigation data includes a plurality 30 of location measurements.

In Example 127, the subject matter of Example 126 optionally includes wherein the navigation sensor includes a tightly coupled inertial navigation system, the tightly coupled inertial navigation system including means for 35 providing a plurality of smoothed inertial measurements and a plurality of smoothed location measurements.

In this document, the term "or" is used to refer to a nonexclusive or, such that "A or B" includes "A but not B," "B but not A," and "A and B," unless otherwise indicated. In this document, the terms "including" and "in which" are used as the plain-English equivalents of 60 the respective terms "comprising" and "wherein." Also, in the following claims, the terms "including" and "comprising" are open-ended, that is, a system, device, article, composition, formulation, or process that includes elements in addition to those listed after such a term in a claim are still 65 deemed to fall within the scope of that claim. Moreover, in the following claims, the terms "first," "second," and

"third," etc. are used merely as labels, and are not intended to impose numerical requirements on their objects.

The above description is intended to be illustrative, and not restrictive. For example, the above-described examples (or one or more aspects thereof) may be used in combination with each other. Other embodiments can be used, such as by one of ordinary skill in the art upon reviewing the above description. The Abstract is provided to allow the reader to quickly ascertain the nature of the technical disclosure. It is submitted with the understanding that it will not be used to interpret or limit the scope or meaning of the claims. In the above Detailed Description, various features may be grouped together to streamline the disclosure. This should not be interpreted as intending that an unclaimed disclosed feature is essential to any claim. Rather, inventive subject matter may lie in less than all features of a particular disclosed embodiment. Thus, the following claims are hereby incorporated into the Detailed Description, with each claim standing on its own as a separate embodiment, and it is contemplated that such embodiments can be combined with each other in various combinations or permutations. The scope of the invention should be determined with reference to the appended claims, along with the full scope of equivalents to which such claims are entitled.

What is claimed is:

- A vehicle maneuver recognition device comprising: a navigation sensor on a vehicle generating vehicle navigation data;
- a processor configured to:

receive the vehicle navigation data from the navigation sensor:

select a data subset of the vehicle navigation data; and identify a first vehicle maneuver event and a second vehicle maneuver event associated with the data subset:

the processor is further configured to interpret the vehicle navigation data as asynchronous serial communication, wherein the interpretation of the asynchronous serial communication includes:

identifying the first vehicle maneuver event as a start bit; identifying at least one interstitial maneuver event associated with the data subset as one or more serial communication bits, the at least one interstitial maneuver event occurring subsequent to the first vehicle maneuver event; and

identifying the second vehicle maneuver event as a stop bit, the second vehicle maneuver event occurring subsequent to the at least one interstitial maneuver event.

2. A vehicle maneuver recognition method comprising: receiving vehicle navigation data from a navigation sensor within a vehicle:

selecting a data subset of the vehicle navigation data; identifying a first vehicle maneuver event and a second vehicle maneuver event associated with the data subset; interpreting the vehicle navigation data as asynchronous serial communication, wherein the interpretation of the asynchronous serial communication includes:

identifying the first vehicle maneuver event as a start bit; identifying at least one interstitial maneuver event associated with the data subset as one or more serial communication bits, the at least one interstitial maneuver event occurring subsequent to the first vehicle maneuver event; and

identifying the second vehicle maneuver event as a stop bit, the second vehicle maneuver event occurring subsequent to the at least one interstitial maneuver event.

3. At least one machine-readable storage medium, comprising a plurality of instructions that, responsive to being executed with processor circuitry of a computer-controlled device, cause the computer-controlled device to:

receive vehicle navigation data from a navigation sensor 5 within a vehicle;

select a data subset of the vehicle navigation data;

identify a first vehicle maneuver event and a second vehicle maneuver event associated with the data subset;

the instructions further causing the computer-controlled 10 device to interpret the vehicle navigation data as asynchronous serial communication, the instructions further causing the computer-controlled device to:

identify the first vehicle maneuver event as a start bit; identify at least one interstitial maneuver event associated 15 with the data subset as one or more serial communication bits, the at least one interstitial maneuver event occurring subsequent to the first vehicle maneuver event; and

identify the second vehicle maneuver event as a stop bit, 20 the second vehicle maneuver event occurring subsequent to the at least one interstitial maneuver event.
